Proposed Environmental Projects - Heading towards creating Integrated Waste Management Complex

Common Hazardous Waste Treatment, Storage & Disposal Facility - Landfill Site

- ▶ The proposed project is coming up at Village Vadgam, Dist. Anand and centrally located to cater various industries across the state.
- ▶ The Environment Clearance from Ministry of Environment & Forest Climate Change, New Delhi has been accorded.
- ▶ The capacity of the land fill site as per the permission received is 420410 tons of hazardous waste.
- ▶ The area earmarked for the TSDF site is 760000 Sq. Ft. belonging to the company.
- ▶ The technology selected is as per the guidelines of the Central Pollution Control Board and Ministry of Environment and Forest.

Common Incineration Facility

- ▶ Thermal oxidation through incinerator is one of the proven technologies for destruction of hazardous waste in all the forms i.e. solid / semi solid / liquid and gaseous, based on the feeding system, so as to render them innocuous in the form of non-toxic and non-hazardous residues.
- ▶ The company has been permitted to install 2 nos. of incinerators with the capacity of 1.5 tons per hour each.
- ▶ The unit is proposed at Village Vadgam, Dist. Anand in 207000 Sq. Ft. area The unit will be adjacent to the proposed landfill site.
